We, the ACD of the Company, are writing to notify you of the changes detailed below. Although the changes do not require shareholder approval and this document does not request you to take any action, we recommend that you read this letter.

Before you read on, please be aware that the following information does not affect the way your investment is run. Your Charteris investment will continue to be managed in the same way as before. There is nothing that you need to do and this is purely for your information.

The Financial Conduct Authority (**FCA**) has confirmed that the implementation of the changes will not affect the ongoing authorization of the Company.

Under the rules of the FCA you are entitled to notice of the changes and this letter constitutes that notice.

Change of name

Host Capital Limited, the Authorised Corporate Director (**ACD**) of the Company was acquired by DMS Governance in August 2019.

We wish to notify you that Host Capital Limited will change its name to DMS Investment Management Services (UK) Limited with effect from [7TH February] 2020 (the **Effective Date**). In order to ensure consistency with the change name of the ACD, the name of the Company and the Sub-Funds will change to the new names set out below with effect from the Effective Date.
